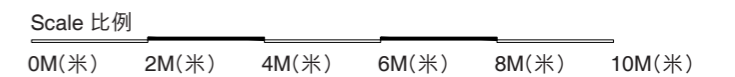

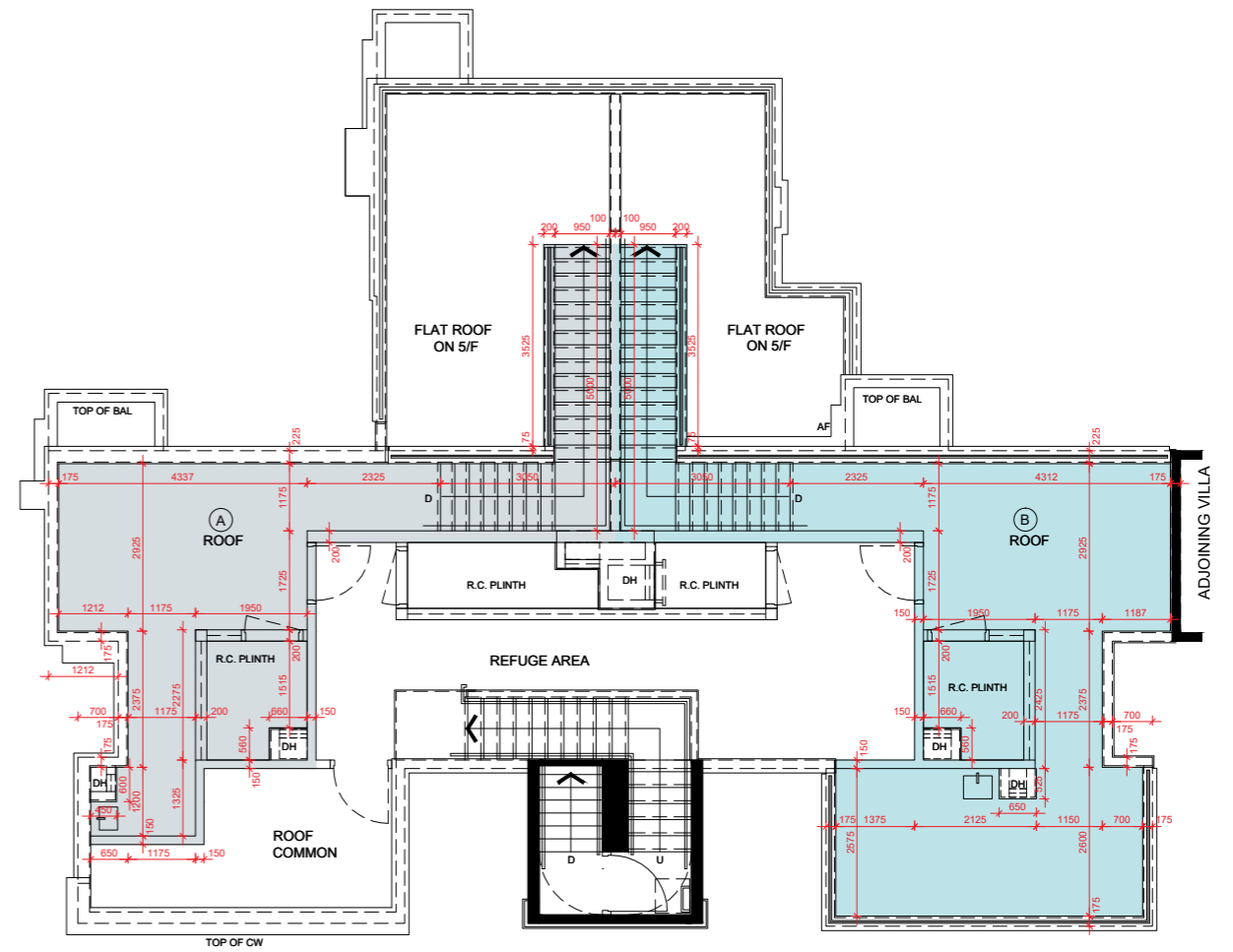
FLOOR PLANS OF RESIDENTIAL PROPERTIES IN THE PHASE
